Thoroughbred Limited 2015 Convention Details

TERMS & CONDITIONS: By registering and paying registration fees for the Thoroughbred Limited 2015 Convention, hereinafter referred to as 2015 Convention, all attendees, guests, and visitors agree to the following terms and conditions;

- Payment of Fees: All registration fees shall be paid to the Registrar by check or money order. Cash may be accepted only on days of the event and where the Registrar is present.
PLEASE DO NOT MAIL CASH!
 - Full payment of all registration fees must accompany the registration form. Do not staple your check or money order to the registration form. Make checks payable to NMRA.
 - Checks returned to the Registrar by the bank for insufficient funds will not be resubmitted for payment and will be returned to the registrant and that registration cancelled. Further registrations will be required to be paid by money order by mail or in person at the event by money order or cash.
 - Do not mail any registrations after May 8, 2015. Please register at the 2015 Convention after that date.
- Lexington is a Family-Friendly Place: Entire families are encouraged to attend 2015 Convention. We have established a single \$25 fee for all immediate family members (spouse, companion, and / or children) of registered 2015 Convention participants. Registered family members will receive name badges, access to tours and clinics. Note: Tickets to the Saturday banquet and extra fare activities must be purchased separately.
- Cancellation of Registration & Refunds: The policy to handle cancellations and refunds includes:
 - All requests for refund shall be in writing prior to the beginning of the convention and addressed to the Registrar.
 - If the registrant cancels his registration for the event after April 1, 2015 and prior to the start of the convention, a refund of 50% of the registration fees less a \$25.00 administrative fee will be made.
 - On a case-by-case basis, other refund amounts may be made at the discretion of the 2015 Convention Registrar. All requests for cancellations shall be made in writing to the Registrar.
 - The event organizers reserve the right to cancel any registration at any time and shall refund the full amount of registration fees to the registrant. Registrants who fail to attend the event without making prior arrangements will not receive refunds.
 - Unless otherwise notified by 2015 Convention organizers, refunds will be processed within two weeks of the end of the convention.
- Hotel & Transportation: All registrants are responsible for their own hotel reservations and transportation to and from the event.
- 2015 Convention Program: Division 10 of the Mid Central Region of the National Model Railroad Association reserves the right to make any changes to the 2015 Convention program, timetables, clinicians and speakers at any time and as necessary.
- Non-NMRA Members: Registration as a member is required to participate in this NMRA event. The registration form provides the option to become a member for a six-month, \$9.95 fee (Railpass). Rail Pass offer is for new members and those who have not been full NMRA members for two years or more. Individuals can join at Rail Pass rates only once: membership renewal will be at the regular membership rate. Rail Pass members can attend conventions and participate in contests, but cannot vote or hold office. Railpass is a one time opportunity. Registrants signing up for the 2015 Convention who desire a Railpass are urged to sign up on-line on the NMRA on-line store under the subpage of Memberships. NMRA will provide you with a temporary membership number which will allow the registrant to fully register for the convention.
- Release of Liability: All attendees agree to hold harmless in any capacity or measure the Division 10 of the Mid Central Region of the National Model Railroad Association for any and all damages while attending the 2015 Convention and all pre-arranged activities of the convention.
- Certain applications on the Thoroughbred Limited 2015 web site may require users to register or to provide personal information in order to make a commerce transaction, to enter a contest, or to subscribe to a newsletter.
